#### The Richard Huck Legion Spirit Award

Nominations for the 2025 recipient of the Richard Huck Legion Spirit Award are now being accepted. The nominating timeline will terminate on Thursday, January 23, 2025, at the conclusion of the Board of Directors Meeting.

Commander Richard Huck was the only commander in the one hundred five-year history of Evanston American Legion Post 42 that transferred to Post Everlasting while in office. The board decided to create an award in his honor that best reflected his spirit, energy, and dedication to the principles of the American Legion.

The purpose of the award is to honor a Post or SAL member, who in the course the year(s) best demonstrated motivation, vitality, and dedication to the principles of the American Legion, specifically Veterans Affairs & Description, National Security, Americanism, and Children and Youth. These "Four Pillars" describe the heart and philosophy of the American Legion in their dedication to Veterans and service to the community, state, and nation.

The ideal recipient of the Richard Huck Legion Spirit Award is not necessarily an officer or holder of office in the Post or SAL, but rather any member who exhibits the principles of the American Legion by active participation in Post programs and activities in a manner that distinguished that individual above others.

The recipient of the Richard Huck Legion Spirit Award is selected by the nomination of any Post or SAL member. Nominations should be legible and as detailed as possible, broken into three sections:

- 1. Personal information, i.e.: Family life, education, employment, etc.
- 2. Military information, i.e.; branch of service, promotions, awards etc. & if SAL, history of the person who allows them to be SAL.
- 3. What he/she has done while a member of Post/Squadron 42

To be considered for the Huck Award. A single paragraph will not be sufficient.

The Nomination will be placed in a sealed envelope, clearly identified as "Huck Award Nomination," addressed to the Post Adjutant.

Following the nomination deadline, all envelopes will be given to the selection committee for consideration by vote. The selection committee will review the nominations and present their selection to the Board of Directors. The award presentation will be made in March at the annual corned beef dinner on Sunday, March16, 2025.

All nominations are due NLT the conclusion of the Board of Directors Meeting on Thursday, January 23, 2025.



#### COURAGE By: Mike Wojciechowski

As an acting Platoon Sergeant in my last few years in the Illinois National Guard, and as a leader, I learned to power down. Some of the troops that are assigned under you are given tasks or missions. These tasks or missions are an essential part of the overall unit's responsibilities and missions that are under the jurisdiction of the Governor of Illinois.

And in doing so, they learn firsthand the meaning of leadership and responsibility. As a leader, you learn to accept responsibility and be able to delegate authority. Leading by example, not being afraid to still get your hands dirty if and when necessary.

In this training, it's the start of the changing of the guard. Passing onto your troops what it takes to be a good leader. Getting your troops to complete missions not because they HAVE to, but because they WANT to. A sense of pride and accomplishment. And this sense is actually in both civilian and military lives.

The spark of inspiration for this article isn't just because of my military experience, but knowing that not all generations understand the need of the passing of the military torch because it doesn't always apply. I remember in the movie "The Help," the mother of the main character tells her: "Sometimes courage skips a generation." This dialogue to me didn't mean how my 2 sons didn't find the need to join the military. But in fact, their courage is in the form of being a father, a husband and a good provider. A roof over their heads, food on their tables, and clothes on their backs. And not just only their basic needs either.

Courage comes in many forms and not just in the military sense. But it's the idea of knowing something that you could fail at but you attempt to achieve it anyway. We learn by doing and in doing so, we learn a valuable lesson: A lesson that's shared from one generation to the next.

I spent four plus years of my young adult life after high school in the United States Navy. I took the Oath of Enlistment before I graduated so I entered into the Delayed Entry Program. Boot Camp for me was in San Diego. After Boot Camp, I was transferred to Great Lakes in North Chicago. I then graduated from Basic Electricity and Electronics School. It was there that I met a number of fleet sailors from both the Navy and the Coast Guard.

I started Gunner's Mate School but I quit the program and unceremoniously was transferred to the East Coast onboard USS John F Kennedy (CV-67), an aircraft carrier in dry-dock at Portsmouth, Va. After retrofitting, she was returned to her home port of Norfolk, Va. It was then that I started to learn of the traditions of the Navy. The same traditions that have been carried on for the last 240 plus years. Respect, discipline, swabbing decks, mess cook duty, ports of call, when, where, and who to salute.

West coast, East coast, Gulf coast, Mediterranean and Caribbean. Not only had I served on one aircraft carrier, but two: I am a Plank-owner on USS Dwight D. Eisenhower (CVN-69). Plank-owner is when you are stationed aboard a ship when it is commissioned. I never really knew how much of an honor it is being a Plank-owner until I started telling other military retirees.

I never crossed the equator so that makes be a Pollywog in naval traditions. But I have to say, considering all the bases, cities, towns, states, and countries I visited while serving in the Navy, I take great pride in knowing I was a representative of the U.S. Navy and the United States of America.

The nickname for a sailor is "Squid." Typically, it's used by sailors to call one another and it's a term of endearment because of the traditions that we've come to love and appreciate. We share these traditions with other sailors who come after us so that they can carry these

traditions on for generations to come. Just as other services share their own traditions to the newest generation of soldiers, airmen, Marines, Coast Guardsman, and newly minted guardians.



#### What is a VSO?

Veterans Service Organizations were established to advocate on behalf of veterans and provide veteran-specific resources. Many are federally chartered (officially recognized by Congress), and are mostly private, nonprofit organizations run by volunteers. The federally chartered designation is especially important when considering using a VSO to help file your claim, as the chartered organizations are also officially recognized by the VA secretary to represent you.

Popular federally chartered VSOs include American Veterans (AMVETS), Disabled American Veterans (DAV), The American Legion, and Veterans of Foreign Wars (VFW).

#### Should You Use a Veterans Service Organization to File a VA Claim?

#### Do I have to use a VSO to help file a claim?

Transitioning out of the military can be an overwhelming, stressful experience for veterans. Not only are you likely moving to a new location and providing for your family, but you also may be recovering from a combat situation and re-learning what life is like in the civilian world. You may need some support as you apply for jobs and college and adjust to not wearing the uniform every day.

In addition to these stressors, navigating the U.S. Department of Veterans Affairs (VA) claims process can be overwhelming. *No one* – not even the VA – would describe this process as easy.

#### What is a VSO?

Veterans Service Organizations were established to advocate on behalf of veterans and provide veteran-specific resources. Many are federally chartered (officially recognized by Congress), and are mostly private, nonprofit organizations run by volunteers. The federally chartered designation is especially important when considering using a VSO to help file your claim, as the chartered organizations are also officially recognized by the VA secretary to represent you.

Popular federally chartered VSOs include American Veterans (AMVETS), Disabled American Veterans (DAV), The American Legion, and Veterans of Foreign Wars (VFW).

#### Why use a VSO to help you file a claim?

The majority of VSOs were started by veterans for veterans. Using a VSO representative means that you will have someone who understands where you've been and what you're up against as you transition out of the military. VSOs also advocate on Capitol Hill for veterans' benefits, are up to date with current legislation affecting veterans, and have posts conveniently located throughout the country.

#### How does a VSO help in the VA claims process?

A VSO representative (also known as a Veterans Service Officer) helps you with the preparation, presentation, and prosecution of claims. Once your claim is filed, they track the claim through the VA system, act as liaisons between you and the VA, and are your official representative by acting as your power of attorney (POA). According to the VA, giving a veteran's service officer the power of attorney allows an appointed VSO representative to "initiate your claim to preserve an effective start date, gather required records and evidence on your behalf, and review your application prior to submission... a VSO serving as your POA is also given 48 hours to review your VA decision to ensure it is correct before it is sent to you."

To be an accredited VA representative, individuals must pass an exam, submit to a background check, and take continuing education courses. These recognized organizations and individuals can legally represent you before the VA. Non-recognized individuals are able to provide information but cannot be your official representative.

#### What are the costs of using a VSO representative?

Using a VSO to help file your claim is free of charge (barring any unusual expenses). Though they would certainly appreciate it, you do not have to be a member of the organization to use their services, and becoming a member is not an expectation.

#### Do I have to use a VSO to help file a claim?

No. If you decide not to use a VSO representative, you could use a VA-accredited claims agent or attorney. The downside is that, unlike Veterans Service Organizations, claims agents and attorneys charge for their services.

Additionally, you always have the option of filing the claim yourself. If you choose to file yourself, you run the risk of not having your paperwork in order, which may cause your claim to be delayed or denied.
